A meeting of the Committee on Finance, Business & Capital Planning was held on Thursday, July 21, 2022 beginning at 9:15 a.m.

The meeting was called to order by Chair Robert Fenza. Chair Fenza advised the Committee that actions and recommendations by the Committee would be reported to the full Board of Trustees for their consideration at the July 22, 2022 meeting.

The Committee unanimously approved the minutes of the May 5, 2022 meeting of the Committee.

The Committee unanimously approved the following resolutions for the Proposed Final Plan Approval and Authorization to Expend Funds, Susan Welch Liberal Arts Building, University Park:

RESOLVED, That the final plans for the Susan Welch Liberal Arts Building at University Park, as designed by Bohlin Cywinski Jackson of Wilkes-Barre, Pennsylvania are approved.

FURTHER BE IT RESOLVED, That authorization to expend funds and award contracts to accomplish the project is approved in the amount of \$127,700,000.

The Committee unanimously approved the following resolutions for the Proposed Final Plan Approval and Authorization to Expend Funds, Field Hockey Stadium Upgrades, University Park:

RESOLVED, That the final plans for the Field Hockey Stadium Upgrades at University Park, as designed by Crawford Architects of Kansas City, Missouri, are approved.

FURTHER BE IT RESOLVED, That authorization to expend funds and award contracts to accomplish the project is approved in the amount of \$12,820,000.

By a vote of eleven-to-one with Trustee Lubrano dissenting, the Committee approved the following resolutions for the Proposed Tuition and Fees Effective for 2022 Fall Semester and General Salary Increase:

RESOLVED, That the proposed tuition and fee rates for 2022 fall semester be approved and that the general salary increase of 2.5% for eligible employees be approved for fiscal year beginning July 1, 2022, as an addition to the interim operating budget approved in May 2022 by the Board of Trustees.

Chair Fenza noted that the Capital Plan and Borrowing Report was updated in Diligent.
