FURTHER BE IT RESOLVED, That authorization to expend funds to accomplish the project is approved in the amount of \$95,300,000.

The Committee unanimously approved the following resolutions for the Proposed Final Plan Approval and Authorization to Expend Funds, Classroom Library Building Renovation, Penn State Scranton:

RESOLVED, That the final plans for the Classroom Library Building Renovation, as designed by Chiang O'Brien Architects of Ithaca, New York, are approved.

FURTHER BE IT RESOLVED, That authorization to expend funds and award contracts to accomplish the project is approved in the amount of \$13,100,000.
